

GENERAL WAIVER AND RELEASE

Hereby Release, Waive, Discharge and Covenant Not to Sue Animation On Display, AOD, The Santa Clara Convention Center, The City of Santa Clara, The Santa Clara Chamber of Commerce and their Respective Governing Bodies, Officers, Directors, Employees and/or Agents, staff, volunteers, other Contest competitors, Contest sponsors, and Contest judges (hereinafter "Releasees") from all liability to the Undersigned, regardless of cause, while the Undersigned is participating in the Contest.

Hereby Agree to Indemnify and Save and Hold Sue Animation On Display, AOD, The Santa Clara Convention Center, The City of Santa Clara, The Santa Clara Chamber of Commerce and their Respective Governing Bodies, Officers, Directors, Employees and/or Agents, staff, volunteers, other Contest competitors, Contest sponsors, and Contest judges from any loss, liability, damage, or cost they must incur due to the presence of any action of the Undersigned in or about the Contest and regardless of cause.

I also grant the use of my voice and any and all recorded and or filmed/video/photographed footage of me, and further waive all rights to any compensation, as a result of my name or likeness being used in any way.

4. Hereby declare that I have read and agree to abide by all rules for the event and will abide by the decisions of the judges.

The Undersigned expressly agrees that the forgoing Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agree that the balance shall, notwithstanding, have full legal force and effect.
